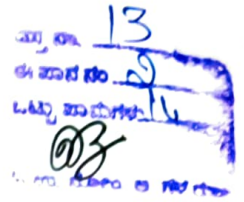

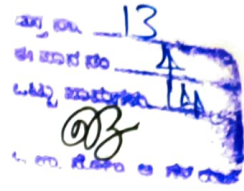


9. To locate first generation students from Dalit, Other Backward Community, Rural and Other Financially Weaker Section of the Society and impart trainings/coaching for military / paramilitary services for their self employment ventures.
10. To develop and foster excellence in the education field of technical, medical, primary, Secondary, pre university, degree colleges and etc.
11. To provide Distance Education facility to those who are not in a position to pursue education in the capacity of regular students.
12. To take over the Management and Administration of social or Educational institutions which are in need of better and efficient Management for their revival and continuation.
13. To establish Government recognized Training institute to provide various self employment schemes in the faculties of Computer, Animal Husbandry and dairy farming etc.


6. ACCOUNTS

9. TRUST PROPERTY

The Trust Property shall consist of:

- a] The initial fund of Rs.2,501/- [Rupees Two thousand five hundred and one only] set a part by the Author to the Trust.
- b] Future contribution, donation, gifts, subsidies, income, funds and other earnings of the Trust out of investments made etc.
- c] Future properties movable and immoveable and properties acquired by the Trust in due course and from time to time.

10. POWERS OF THE TRUSTEE

Without prejudice to the generally of the vested in them the Trustees shall have the specific powers. The decision of Managing Trustee along with the Secretary taken in the interest of the Trust shall be final and under no circumstances other Trustee or the Trustee if inducted in due course are empowered to question, appeal, move for amendments or to suit against or claim against such decisions. The Managing Trustee along with the Secretary shall be entitled to exercise the powers vested as follows:

- a. Salaries, allowances, rents, taxes, dues and duties such other recurring and operating expenses.
- b. The cost of any amenities, office accommodation, equipments, and buildings acquired from time or as and when required.
- c. To acquire any new properties, movables, and or immoveable forming part of the Trust property as the Trustee shall thinks fit.
- d. To fix and pay wages, salaries and allowance to staff members and field functionaries and research and development experts, scientists, employed or engaged by the Trust in the carrying out of activities of the Trust.

The parts of the corpus of the Trust shall utilized by the Trust in giving donations to educational, charitable Trusts, Scholarships, award, medicines to deserving poor students and sufferers of natural calamities and such other charitable purpose or purpose of public utility as the Trust think fit without affecting the overall financial positions of the Trust.
- i. To barrow loans and donations means from banks, hand loans, and other institutions as the Trust determines necessary to carry out its objectives, activities and establishments including hand loans.
- j. To appoint and or to engage any persons for any official, executives positions on such remuneration as determined by the Trust and alter the terms of their services and to terminate their services in accordance with law.
- k. all funds rights, claims, demands of every description belonging to our pertaining to the Trust and which may be acquired from time to time invest with the Managing Trustee and secretary jointly.
- l. To delegate to any person or any foregoing powers, subject however to Managing Trustee and secretary jointly retaining, control over the action and conduct of the person to whom the powers are delegated.
